- A. The observations of the Inspection Report underneath will be complied with and a report thereof must be submitted at the earliest.
 - The college should strictly adhere to the fee-structure and intake capacity (100) recommended by the University of Gour Banga.
 - ii. The college in no case should deviate from the stipulation of holding classes in at least 180 working days during the session. An academic calendar confirming the plan should be submitted immediately.
